# Carroll ISD School Safety & Security Committee Meeting

## **Meeting Minutes**

## **August 2, 2022**

The meeting of the Carroll ISD School Safety & Security Committee (SSSC) was called to order by the Executive Director for Policy & Student Services, Dr. Tamy Smalskas, on Tuesday, August 2, 2022, at 4:03 PM in the Carroll ISD Administration Center, 2400 N. Carroll Avenue, Southlake, TX 76092.

The Superintendent welcomed committee members and ensured members of the district's continued commitment to the safety and security of all CISD students and staff.

# Overview of Texas School Safety Center (TSSC) Committee Guidelines

Dr. Smalskas gave a brief review of the March 2, 2022 Carroll ISD School Safety & Security Committee Meeting and gave an overview of the TSSC Committee guidelines including its responsibilities, guidance and best practices.

#### **Governor's Orders**

The committee received an overview of recent expectations from Governor Abbott and an update on where Carroll ISD is per orders including a safety door audit. Assistant Superintendent of Operations, Matt Miller, discussed the exterior door audit and the exterior door numbering system. Also discussed were building security additions and the district's Rapid Responder system. Committee members were informed about the Texas Education Agency (TEA) Summer Safety Audit.

# Recent trainings with campus principals and expectations

Dr. Smalskas and SRO Supervisor, Cpl. Hernandez, gave an update on recent staff training and how it impacts Carroll ISD. Topics discussed included:

- a. Standard Response Protocol Training
- b. Civilian Response to Active Shooter Events Training (CRASE)
- c. Behavioral Threat Assessment Training
- d. Technology training on safety tools
- e. Development of the Emergency Operations Plan (EOP)

Next steps include completion of the Summer Safety and Security Checklist for Principals, a Standard Reunification plan, Bleeding Control training, and Completion of

the Emergency Operations Plan. Other topics discussed included development of a plan to address other emergency situations such as an airplane crash, and training for volunteers.

## OTHER QUESTIONS AND DISCUSSION

The committee was informed that campus safety walks were completed in May 2022. The committee was informed that the District is conducting an LED lighting pilot program at Carroll Middle School.
